



GENERAL TERMS FOR MOBILE HOME RENTALS

In high season, the arrival (from 3 pm) and the departure (before 10 am) will be on Wednesday or Saturday (minimum 7 nights). In low season, the arrival or the departure will be from 10:30 am to 12:00 and from 3:00 pm to 6:00 pm, after approval of the reception (minimum 2 nights). The rental rate includes water, electricity and gas, one vehicle per pitch. **TENTS ARE FORBIDDEN ON THE PITCHES.**

Possibility to order sheets : 12 € the kit 140 (+ 2 pillowcases) et 10 € the kit 80 (+ 1 pillowcase). Baby Kit (per week) : 21 €. The tourist tax is added : an extra of 0.61 € per night per person 18 years old and over.

The booking will only take effect on receipt of the down payment. Any booking must specify the names involved.

The balance of the stay will be paid, at the latest, 30 days before arrival and the tourist tax the day before leaving the campsite.

PETS ARE NOT ALLOWED IN THE RENTALS.

Each rental property is kitted out with kitchen equipment, tableware and bedding (pillows, duvets or blankets, with the exception of the bed and bathroom linen). The equipment is subject of an inventory, each tenant has to check it on arrival and inform the reception that day if there were any anomalies.

A deposit 250 € for each rental is required on arrival, it will be refunded within 2 weeks subject to there being no damage or missing items. This deposit doesn't constitute a liability limit. A cleaning deposit of 95 €, also given at arrival, will be returned on the day of departure from the campsite, after an inventory of fixtures fixed by prior appointment with the reception at the latest the day before departure.

The tenant is responsible for cleaning the mobile home. 95 € will be retained if it hasn't be done.

Each tenant has to respect the campsite's policies and procedures. Bath shorts forbidden at the swimming-pool.

Cancellation : More than 30 days before your intended arrival, a sum of 95 € will be retained. Less than 30 days before your intended arrival, the down payment (low season) or the total amount of the stay will be retained. Any stay which is interrupted as a result of the holiday maker will not result in any form of refund.

Optional cancellation insurance: 3,5 % of the amount of your stay (except booking fee and tourist tax), minimum 15 €. Conditions available on our website www.camping-vendee-cayola.com or on demand.
